We need to find a way to be able to get treatment, without the stigma and, at the same time, we need to avoid the appearance of treating mentally ill people like they are crazy or gross. That is, of course, unless you really are mentally ill. Treatment of people with mental illness should be largely seamless. We should get prescriptions and hospitalization and out of control health bills paid. The only place that it makes sense to treat someone in a different way is in an institution if there are clear medical reasons for doing so, such as danger to self or others, aggression, or some other reason that the State feels is necessary. It is not unusual for people to be involuntarily committed to mental institutions and left there for years, even decades. Alcohol and drugs are a different story. I don't think that we should never talk about people using alcohol and drugs. But neither should we treat people like automatons who will have the same behavior if we give them a drink. I don'
